**Checklist For Application:**

- Copy of dated sales receipt
- Copy of Yellow EnergyGuide Label
- Completed Application

By participating in our We Save program, you can keep costs down and earn rebates when you purchase a Quality Installed (Q.I.) ENERGY STAR qualified air source heat pump.

**What rebate can I earn?**

SEER 14-14.9\* = **\$225** | SEER 15-15.9 = **\$300** | SEER 16+ = **\$400**

\* Split System units must meet minimum 14.5 SEER criteria.

**What is Quality Installation?**

Quality Installation ensures that equipment is installed properly and consists of the following key elements: equipment sizing, proper refrigerant charge and air flow, and duct sealing. **To qualify for the Q.I. Air Source Heat Pump rebate, your contractor must verify that all items included in the Quality Installation Checklist on the rebate application were performed.**

**What does it mean to be ENERGY STAR qualified?**

ENERGY STAR Tier 2 requirements for air source heat pumps took effect **January 1, 2009**. These requirements are as follows:

Product Type	SEER	EER	HSPF
Split System	≥ 14.5	≥ 12	≥ 8.2
Single Package Equipment	≥ 14	≥ 11	≥ 8

**How Do I Qualify?**

- Residential customers receiving electric service from a local municipal electric utility that is a participating member of MMPA are eligible for rebates when they purchase Quality Installed ENERGY STAR air source heat pumps.
- **At time of purchase, air source heat pump must be on current ENERGY STAR qualified list and labeled accordingly. (Ask your dealer which models are currently listed.)**
- **To qualify for rebate, unit must be installed following Quality Installation procedures and ALL boxes in the Quality Installation Checklist on the rebate application must be checked "Yes".**
- Information on rebate application must match information on receipt/invoice exactly.
- The program is applicable only for the purchase of new ENERGY STAR qualified air source heat pumps for installation in new or retrofit applications where the electricity is supplied to the participating local municipal electric utilities by MMPA.
- The customer must purchase both the condensing unit and the coil to be eligible for rebate and will not receive rebate if purchasing only a condensing unit without replacing the coil.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebate applications must include complete contractor and equipment information and include: a copy of dated sales receipt/invoice including manufacturer, model number serial number, SEER rating. Failure to complete the rebate application will result in rejection of the rebate request.
- Utility reserves the right to conduct random inspections to verify installations at the address indicated on the rebate application. Customer agrees to provide reasonable access to the residence to accommodate this inspection.
- Rebates are limited to one rebate per customer account per year.
- Rebate requests are processed on a "first-come first-serve" basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time. The customer is responsible for checking with local municipal electric utility to determine whether program is still in effect.
