**Checklist For Appliance Rebate Application:**

- Copy of dated sales receipt
- Copy of Yellow EnergyGuide Label
- Completed Application

**Checklist For Refrigerator Recycling Bonus Rebate Application:**

- Copy of proof of recycling receipt
- Completed Application

By participating in the We Save program, you can save energy, keep costs down and earn rebates when you purchase a new ENERGY STAR qualified appliance and recycle an operating refrigerator.

**What rebates can I earn?**

- Refrigerator = **\$25**
- Dishwasher = **\$25**
- Clothes washer = **\$50**
- Refrigerator Recycling Bonus = **\$50**

**What does it mean to be ENERGY STAR Qualified?**

**Refrigerator**

- Can save more than **\$45** per year (when replacing 10 year old units) and more than **\$130** per year (when replacing 20 year old units)
- Use at least **20% less** energy than required by current federal minimum standards and **40% less** energy than conventional models sold in 2001 and **50% less** than models manufactured prior to 1993

**Dishwasher**

- Can save more than **\$30** per year (when replacing 15 year old units)
- Use at least **41% less** energy than the federal minimum standard for energy consumption

**Clothes Washer**

- Can save on average up to **\$50** per year
- Can save **7,000** gallons of water per year

**How Do I Qualify?**

- Residential customers receiving electric service from a local municipal electric utility that is a participating member of MMPA are eligible for rebates when buying ENERGY STAR qualified appliances.
- **Appliance must be ENERGY STAR qualified and labeled accordingly to be eligible for rebates. At time of purchase, appliance must be on current ENERGY STAR list. (Ask your dealer which models are currently listed.)**
- Appliance must be installed in a home that receives electric service from a local municipal utility that is a participating member of MMPA.
- **To qualify for Refrigerator Recycling Bonus rebate, refrigerator must be in operating condition and proof of recycling is required.** If unit is hauled away by retailer, retailer must certify that unit will be recycled and not resold. If refrigerator is replaced, it must be replaced with ENERGY STAR qualified refrigerator.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebate applications must include complete dealer and appliance information and: a copy of dated sales receipt/invoice including manufacturer, model number serial number, annual energy usage (kWh/year). Failure to complete the rebate application will result in rejection of the rebate request.
- Rebates are limited to one rebate per appliance per customer account per year.
- Rebate requests are processed on a "first-come first-serve" basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time. The customer is responsible for checking with its local municipal electric utility to determine if the program is still in effect.

**COMPLETE THESE FIVE EASY STEPS TO GET YOUR BONUS REBATE.**

To qualify for the Refrigerator Recycling Bonus Rebate,

- Refrigerator must be in operating condition prior to removal.
- If replaced, refrigerator must be replaced with ENERGY STAR qualified refrigerator.
- Refrigerator removed must be recycled.
- Proof of recycling must be provided with rebate.
