Checklist For Application:

- Completed Home Energy Audit Request Application

By participating in our We Save program, you can discover ways to save money and energy by having a Home Energy Audit conducted by our trained professionals at a reduced cost.

What is my cost for a Home Energy Audit?

Basic Home Energy Audit = **\$35*** (valued at \$150)

Advanced Home Energy Audit = **\$100** (valued at \$250)

** Fee waived on Basic Audit for qualifying low-income households (see request application for more details).*

What is a Home Energy Audit?

A home energy audit is an inspection of your home that can help improve energy efficiency and comfort.

A Basic Home Energy Audit includes the following:

- ✓ Analysis of home's historical electrical usage
- ✓ Short interview with homeowner
- ✓ Moisture Assessment (measure relative humidity, check mold/mildew, identify cause(s) of moisture)
- ✓ Detailed report addressing areas of concern; estimated energy savings, cost and payback periods; and recommendations for improving energy efficiency
- ✓ Blower door test (measures air infiltration, air leaks)
- ✓ Inspection of building shell (attic, sidewalls, basement)
- ✓ Safety inspection of mechanical systems (CO and draft testing)
- ✓ Ventilation System Assessment (inspect, measure ventilation)

An Advanced Home Energy Audit includes the services above and also:

- ✓ Infrared camera inspection (identify areas of heat loss and air infiltration through doors, windows, walls, attic)
- ✓ CD containing digital and infrared photos

How Do I Schedule a Home Energy Audit?

To schedule a home energy audit, simply complete the attached request application and submit it to your hometown electric utility.

How Do I Qualify?

- Residential customers receiving electric service from a local municipal electric utility that is a participating member of MMPA are eligible for a reduced price home energy audit.
- **The Home Energy Audit must be performed by one of our trained professionals.**
- The Home Energy Audit must be conducted in a home that receives electric service from a local municipal utility that is a participating member of MMPA.
- Reduced price audits are limited to one audit per customer account per three years.
- Audit requests are processed on a "first-come first-serve" basis. Funding for the program is limited and any requests received after the funding limit has been reached will not be approved. Program, qualifications, and amounts are subject to change at any time. The customer is responsible for checking with the local municipal electric utility to determine whether the program is still in effect.
- Qualifying customers must apply for 2011 rebates by November 30, 2011.
