What rebate can I earn?

Benefits of Electric Outdoor Equipment Over Gas-Powered Equipment

- ✓ **Better for the environment.** Don't emit harmful air pollutants.
- ✓ **Easier to start.** There's no pull cord, simply press a button.
- ✓ **Easier to operate.** Just charge the battery. Lighter in weight and easier to maneuver.
- ✓ **Quieter.** No need to wear hearing protection and you won't disturb your neighbors.
- ✓ **Less maintenance.** No more dealing with funnels and gasoline cans or having to change oil, air filters.

Rebate Qualifications and Program Rules

- Residential customers receiving electric service from the City of North St. Paul are eligible for rebates when they purchase qualifying electric outdoor equipment.
- Equipment must be battery-powered and cordless.
- Leased, used, or pre-owned equipment is not eligible for rebate.
- Rebate will be issued to the customer only. Rebate shall not exceed 50% of price paid.
- Limit two riding lawn mowers and five of each other type of equipment per customer account per year.
- Rebate forms must include: (1) Rebate Application and (2) dated sales receipt. Incomplete rebate applications will not be processed.
- Information on Rebate Application must match sales receipt.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by November 30, 2026.
