2024 Residential LED Lighting & **Ceiling Fan Rebate Instructions**

By participating in the We Save program, you can save energy and earn a rebate when you purchase energy efficient LED lighting for your home.

What rebate can I earn?

LED bulb	50% of price, up to \$5/bulb	general purpose (A15/19/21/23), reflector/flood (BR30/38/40, PAR16/20/30/38), candle, globe					
LED T8 linear lamp	50% of price, up to \$5/lamp	must be Design Lights Consortium® (DLC) qualified					
LED fixture	50% of price, up to \$15/fixture	downlights, under cabinet, bath vanity, wall mount, security/flood light					
Ceiling fan w/ light kit	50% of price, up to \$25/fan	ceiling mounted fans with 29-54" blades, must includ LED light kit					

LED Lighting Facts

- LED stands for light emitting diode. It's more efficient and lasts longer than incandescent and fluorescent lighting. It also produces less heat, which makes it safer to use and can save you money on home cooling.
- LEDs are directional light sources which means they emit light in a specific direction. This is different from incandescent and fluorescent lighting which emit light and heat in all directions.
- LED lighting typically does not "burn out" and instead the brightness dims slowly over time.
- DLC qualified LED linear replacement lamps have a DLC logo on their packaging and meet minimum technical specifications, including a minimum 5-year warranty.

Rebate Qualifications and Program Rules

- Residential customers receiving electric service from the City of Buffalo are eligible for a rebate when they purchase LED bulbs, fixtures, ceiling fans with light kits, and DLC qualified LED T8 linear lamps.
- Rope lights, tape lights, battery-powered lights, and ventilation/exhaust fans are not eligible for this rebate.
- See Rebate Forms Checklist below for required documentation. Incomplete applications will not be processed.
- Information on rebate application must match sales receipt.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebated bulbs and fixtures may not be used for resale.
- Limit one rebate per customer account per year. Total rebate limit of \$400 paid to customer.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
